# **Member-Get-Member Programme Terms and Conditions**

## **Programme**

- 1. ReCube Limited ("ReCube") Member-Get-Member Programme ("MGM Programme") commences from now until further notice, both dates inclusive (the "Programme Period").
- 2. By participating in this MGM Programme, participants are deemed to accept these Terms and Conditions ("T&Cs").

## **Eligibility**

- 3. To be eligible for the MGM Programme, the referrer ("Referrer") must:
  - a. Be a valid account holder of a ReCube account; and
  - b. Have referred a Referee (as defined below) to register an account with ReCube during the Programme Period.
- 4. To be eligible for the MGM Programme, the referee ("Referee") must:
  - a. Be a new customer and not hold any account with ReCube before the Programme Period; and
  - b. Have successfully registered an account with ReCube.
- 5. During the Programme Period, the Referrer will be eligible to the Referral Rewards under Clause 7a if the conditions below are fulfilled ("Successful Referral")
  - a. The Referrer must forward the designated invitation code he/she received relating to the MGM Programme to the Referee;
  - b. The Referee must successfully register a ReCube account with the designated invitation code; and
  - c. Such other additional requirements imposed by ReCube are fulfilled.
- 6. The Referee will be eligible to the Referral Rewards under Clause 7b if the conditions below are fulfilled:
  - a. During the Programme Period, the Referee must successfully register a ReCube account with the designated invitation code;
  - b. Such other additional requirements imposed by ReCube are fulfilled.

#### **Referral Rewards**

- 7. Upon fulfilling clauses 5 and 6, the Referrer and the Referee shall be rewarded according to the criteria as set out below which will be adjusted from time to time ("Referral Rewards").
  - a. Based on number of Successful Referral, Referrer will be entitled to the following rewards:

Referrer Rewards	Number of Successful Referrals
500 ReCoin	1
1000 ReCoin	3
1500 ReCoin	5

- b. Referee will be entitled to a 500 ReCoin reward upon successful registration of ReCube account.
- 8. The Referral Rewards will be credited to the Referrer and Referees' accounts via the mission function after fulfilling the Referral Rewards criteria/conditions/requirements. Referrers and Referees need to claim the Referral Rewards themselves via Rewards [Missions] in ReCube App. Referrers and Referees need to claim the rewards in time, and rewards that have not been claimed will expire and will not be reissued.
- 9. ReCoin can be redeemed for certain rewards. Terms and Conditions of ReCoin apply for redemption. ReCube is not obligated/obliged to notify participants of any changes or latest announcements about relevant Terms and Conditions.
- 10. Referrers must not refer themselves as Referee. A Referee who has been successfully referred by one Referrer cannot be repeatedly referred by the same Referrer or other

Referrer(s).

- 11. Each referee can only use one invitation code. If the referee meets the criteria/conditions/requirements of the programme, he/she will be awarded the corresponding Referral Rewards in the programme.
- 12. All Referral Rewards cannot be transferred, returned, exchanged or converted into other forms, unless otherwise specified.
- 13. ReCube will not entertain any request to alter the Referral Rewards.
- 14. If the Referrer or the Referee does not receive the Referral Rewards within 30 working days after fulfilling the Referral Rewards criteria/conditions/requirements, the Referrer or the Referee must inform ReCube. ReCube will arrange for the crediting of the Referral Rewards to the Referrer or the Referee after it has confirmed the Referrer and the Referee have fulfilled the conditions/requirements.
- 15. If the Referee takes steps to close his/ her account within 12 months after the Referee registered it, ReCube has the right to deduct the total Referral Rewards amount paid or payable to the Referee from his/ her account.

#### **General**

- 18. ReCube reserves the right to adjust, withdraw or cancel the MGM Programme, the Referral Rewards, and to amend or revise any of these T&Cs from time to time without prior notice and without assigning any reasons whatsoever to the extent permitted by applicable law.
- 19. ReCube may, from time to time, impose daily limitations on the number of redemption of invitation code.
- 20. ReCube reserves the right to suspend participation of the Referrer or Referee in the MGM Programme and deduct the total amount of Referral Rewards paid or payable to the Referrer or Referee if ReCube has reasonable ground to believe an account has been opened with the invitation code from an improper distribution channel (for example advertise and impersonate the invitation code to the Referee as if it is officially distributed by ReCube).
- 21. ReCube will not collect the personal data of the Referee upon Referrer's referral.
- 22. The MGM Programme does not involve direct marketing elements.
- 23. In case of any ambiguity, doubts or disputes arising out of or under any of these terms and conditions or any communications, the decision of ReCube is final and conclusive

in all circumstances without assigning any reasons whatsoever and no correspondence will be entered into.

- 25. To the fullest extent permitted by law, each Referrer and Referee agrees that in no event shall ReCube be liable for any loss or damages which he/she may suffer or incur, in connection with the MGM Programme.
- 26. No one other than the Referrer, the Referee and ReCube will have any right under the Contracts (Rights of Third Parties) Ordinance (Cap. 3) of the Laws of Hong Kong to enforce or enjoy the benefit of any of the provisions of these T&Cs.
- 27. These T&Cs are governed in all respects by and construed in accordance with the laws of the Hong Kong Special Administrative Region. The parties submit to the jurisdiction of the courts of the Hong Kong Special Administrative Region.
- 28. In the event of any discrepancy or inconsistencies between the English and Chinese versions of these T&Cs, the English version shall prevail.
